10. *If the Institution Contravenes any of the provisions of the NCTE Act, Rules, Regulations, and orders made or issued thereunder, the action including withdrawal of recognition shall be taken by the Regional Committee concerned under the provisions of Section 17(1) of the NCTE Act 1993.*
